WHMC Accomplishments

As we close the 2015-2016 fiscal year, WHMC is looking back on our accomplishments this past year and the incredible impact that YOU - our donors, volunteers and supporters - have made to help us reach our goals to provide peaceable solutions to people in our community and expand our

conflict education programs for youth.



Court and Self-Referred Mediation:

- Conducted a total of 354 court and self-referred mediation with the help of 40 active volunteer mediators
- Welcomed a total of 15 new mediators to our pool of talented volunteer mediators

Foreclosure Mediation:

 Served 47 families facing foreclosure as part of our Foreclosure Pilot Program

Peer Mediation:

- During the 2015-2016 School Year,
 WHMC trained 252 peer mediators
 with the potential to directly and/or indirectly impact 5,210 students
- Expanded the program from one middle school in SY2012-13 to three middle schools and three high schools in SY2015-16, including the largest high school in West Hawai'i
- In an effort to toward program sustainability at schools, one school has taken the step in adding a Peer Mediation/Peace Studies elective course in which nearly every mediator is enrolled
- Provided numerous opportunities for high school mediators to mentor/serve as trainers/assistants for elementary mediators

Community Outreach & Training:

• WHMC attended and hosted a total of 14 training's with topics covering

Facilitation, Agreement Writing, Landlord Tenant, Domestic Violence, Digital Storytelling, Access to Justice and two Basic Mediation trainings

 Participated in 18 separate community outreach events, including neighborhood watch meetings, Crime Prevention discussions, University volunteer fairs and Rotary meetings
